








"Early Intervention Staff and the Board of DD feel strongly that identifying and addressing developmental delays in children between the ages of 0-3 is vital."

"The Board of DD acts as a partner with the ESC and all county schools. The Board is committed to preparing students for life after school and accomplishes this with specialized staff that attend IEP Meetings, educate school faculty, and empower students to make life choices that best serve them."

SCHOOL AGED / TRANSITION

- 1. Provided a summer community exposure program to three youth between 14-15 years old. They participated in community based activities to increase interpersonal skills.
- 2. Provided a summer work exposure program to six youth between 16-17 years old. They participated in job tours and gained a deeper understanding of work opportunities in Mercer County.
- 3. Provided a summer work / competitive employment opportunity to seven young adults who were at least 18 years old and transitioning out of school.
- ** Due to the pandemic, provider capacity was severely limited thus affecting our ability to offer these services.

COMMUNITY INCLUSION / INTEGRATION

- 1. Provided additional administrative assistance to the Arc of Mercer County. The Board of DD was awarded over \$284,000 to assist the Arc of Mercer County at securing their 13th home to serve individuals with disabilities (5 in Celina, 6 in Coldwater, 1 in Maria Stein, and 1 in St. Henry).
- Worked with the Arc of Mercer County and Special Olympics offering support for the recreational, educational, and social programs that are made available to all served by Mercer DD.


"Due to DODD and CMS rule changes, the emphasis is towards community employment and away from facility-based employment."

EMPLOYMENT

2021 Results:

- 1. Every eligible adult identified their place on the path to employment and their career plan.
- 2. The Board served 13 individuals who have retired from the workplace.
- 3. The Board partnered with three separate and distinct agencies to provide employment services.
- 4. The Board supported 31 individuals in group (enclave) settings to eventually build the skills for competitive employment.

With direction from DODD, by the end of 2021, we had returned to approximately 90% of individuals receiving the same services they were prior to March 2020.



TRANSPORTATION

2021 Outcomes:

1. Added an independent transportation provider as an additional option for individuals.

ADVOCACY / EDUCATION


- Conducted seven SALT (School to Adult Life Transition) and seven SALT-Teens Programs to educate individuals and families.
- ESC transition teachers regularly consult with the Board's Transition Specialist for information regarding available services and assistance available to their students.
- Wrote and was awarded a CATCH Grant to create a website highlighting transition age services, programs, and support agencies for educators and families in Mercer County.
- **4.** Created a DSP Scholarship to encourage DSPs to to remain in the field.

PROVIDER RELATIONS

2021 Outcomes:

 Board of DD contracted Medicaid services to 23 agency providers and 27 independent providers (an increase of 5 independent providers). Medicaid service costs exceeded \$100,000 with 10 agency providers.







FISCAL MANAGEMENT
