## Goal: Making the Fair Accessible to All

# Changing Table Available for Adults, Older Children

The Mercer County Fair is a place to enjoy the lights and sights of the midway, visit the livestock barns and commercial exhibits, eat great food and catch up with folks you haven't seen for a while.

It's been that way since it was founded in 1852. Now, Mercer DD is working with the Mercer County Fair to make the event easier to attend for people with disabilities.

This year, the fair will have an adult changing table, courtesy of Mercer DD. It will be located in the family restroom in the fair's commercial building. The table, for adults and older children, has power controls so it can be raised and lowered.

"Sometimes, people with disabilities have not been able to enjoy everything the fair has to offer, because there has not been a place where it's easy for their caregivers help them with restroom needs," said Mercer DD Superintendent Shawn Thieman. "So either they don't go to the fair, or they have to go home then come back. They

can't enjoy the fair like every-body else."

Mercer County Fairground Manager Cara Muhlenkamp said the fair welcomes the addition of the changing table, plus any insights that individuals with disabilities and their family members can offer to the fair. "We are happy to make

relationships with people who are experts in that area," such as Mercer DD, she said. "As we sat around the table planning for the fair, we realized we don't know enough about this. We need to pull in people who understand how we can be better stewards of this and other events at the fairgrounds."

Cara said that the public can reach out to the fair through its social media channels or its website (mercercountyohiofair.com) with

suggestions on how to make the fair and other events more accessible for all. "Sometimes we can make changes right away," she said. "Sometimes we need a little more time."

When the fair is over, the adult changing table will be in use at Mercer DD's facility on Mud Pike west of Celina.

This ongoing discussion is part of a larger movement across the state to ensure that adults' needs can be managed more easily when they are out and about. ### Wage Increase for DSPs Coming Next Year

Every two years, we Ohioans get to experience a statewide process called the biennial budget. I am not sure that I have learned to enjoy this process, but I have certainly become aware of its importance in my life. The budget process has large implications on Ohio's DD system--both statewide and locally.

The most meaningful topic of this year's approved budget is our success at gaining significant

increases to Medicaid reimbursement rates! The original version of the budget included large state appropriation increases to the average statewide hourly wage for DSPs in Ohio's

DD waiver system.

At the request from County Boards, the final version of the budget included a local appropriation from county boards of DD to increase the average statewide DSP wage by an additional \$1/hour. This means that the statewide average hourly wage for DSPs in Ohio's DD waiver system will increase to \$18/hour beginning January 1, 2024 and to \$19/hour beginning July 1, 2024.

Wage verification measures were also included in the final version of the budget to require DODD to submit annual reports documenting that increased wages are being paid to DSPs. The passage of these investments was no small feat and should be widely celebrated.

A few other highlights from the recently approved budget include:

• Language that permits,

rather than requires, DODD to charge a fee up to the current 1.25 percent of all Medicaid claims paid. This provision will permit wide flexibility so that fees collected can be used to provide technical and financial support to county boards related to waiver match responsibilities. This request from county boards was to allow for limited support in instances where a county board is at risk of fiscal emergency due to the increase in costs from the wage increase.

- An allowance permitting a certain number of county board members to participate and vote in board meetings through video or other telecommunication platforms. All board members must still attend a minimum percentage of meetings in person, and there must be a minimum number of board members present in person at any given meeting.
- A new requirement for county commissioners to appoint a person eligible for services to all county boards. County commissioners have always been required to appoint one individual who is a family member of a person eligible for DD services, whereas this provision also requires county commissioners to appoint at least one person eligible for DD services. The probate judge may appoint at least one person eligible for DD services, which would satisfy the county commissioners' requirement to make such an appointment. The effective date of the new requirement will be July 1, 2025.

Adult Changing Table Awareness.)

The adult changing table isn't the only addition to the fair this year for people with disabilities. Children age 10 and up can participate in opportunities to show animals in the junior fair, alongside 4-H members. They go through a half-hour education session where they learn about the animal they will show (sheep, rabbits or dairy). They then go before a judge with the animal and a 4-H member. Participants will receive a ribbon.

"We belong to the International Association of Fairs and Expos, and we are constantly hearing about what's working at other fairs and events, and we feed off what others are doing" to improve accessibility at the local fairgrounds, Cara said. "We have goals that we are working toward that would be beneficial for people with disabilities."

Mercer DD has been a part of the fair for many years with a well-attended booth in the commercial building. Helping make the fair more accessible to all is the natural next step, Shawn said.

"Many of the people we serve love the fair. It's an exciting place for people with many different interests," he said. "Since it was first founded, the fair has showcased the best that our local communities have to offer. So what better place for us to lend a hand to make it more accessible to all people?"
