The increase in July will not be as much. We do not have those numbers projected as of yet. This was to help with DSP wages—some of the agencies have been able to hire men as DSP providers.

Parents as Caregivers---this has come about due to COVID changes. Children with extraordinary needs—parents can be paid caregivers/employed by an agency if no one else is available or qualified. There will be assessments/qualifiers put in place. There will be more information coming as this rolls out.
