ARC Housing Report---Gregg went over ARC Housing. Gregg handed out a packet with a list of all the houses and their locations. The houses are in Celina, Coldwater, Maria Stein, and St. Henry. Currently we have between 45—47 individuals in these houses. We are not fully occupied; we have some openings for emergency cases. Once a house is bought, the renovations start right away. We make everything handicap accessible. We work with Capital Housing, 90% of purchase price comes from Capital Housing. The ARC takes care of all maintenance of the homes, lawn care, snow removal. The board is impressed by all the houses and the work that Gregg and Kathy Coon do. A big Thank You to Gregg and Kathy.

Superintendent Discussion

Potential Board Member---The State of Ohio has passed a recent law that said every board of DD needed to have a member served to be on that board. This will happen when the next board member's term expires. After some discussion with the SSA department, it was felt that Tori Heck would be a great addition to our board. Tori agreed to come to a few meetings this year to see if she would be interested in this. Shawn introduced Tori and The board Members introduced themselves to Tori.

Activities Aide Positions---Addison Brewer has accepted a position at Wright Patterson. She has worked with Sam in Special Olympics, activities and respite care. She has been awesome and will be missed. We will be hiring someone to replace her. So, if anyone on the board knows a person going to College that would want a position like that, please let us know. This is a part time position---It is mostly evening and weekends.

Medicaid Funding---With the Presidential change, Trump is looking for way to cut budgets—this may include Medicaid and funding. Could be a significant cut. Might be moving the Medicaid Match numbers. Shawn will keep an eye on this and keep the Board Members informed.

Property TaxShawn has been hearing things about the property taxes due to the increase. Mercer
County Board of DD is getting the same numbers as before. Those increases did not go to us.
