*“Due to DODD and CMS rule changes, the emphasis is towards community employment and away from facility-based employment.”*

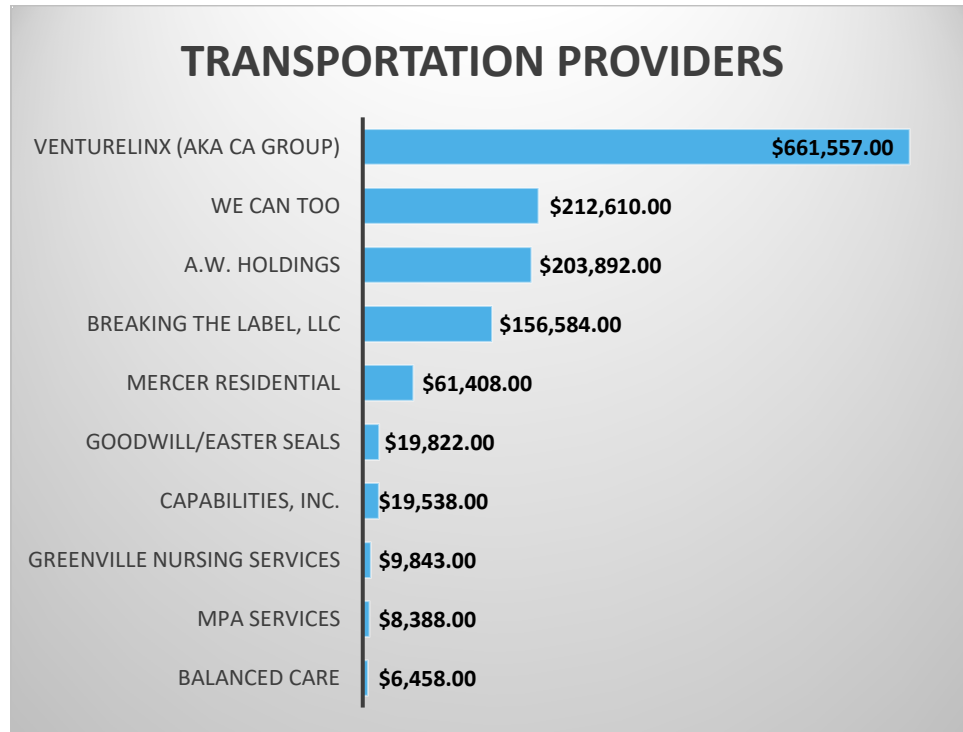

**THREE SEPARATE AND DISTINCT AGENCIES PROVIDE EMPLOYMENT SERVICES.**

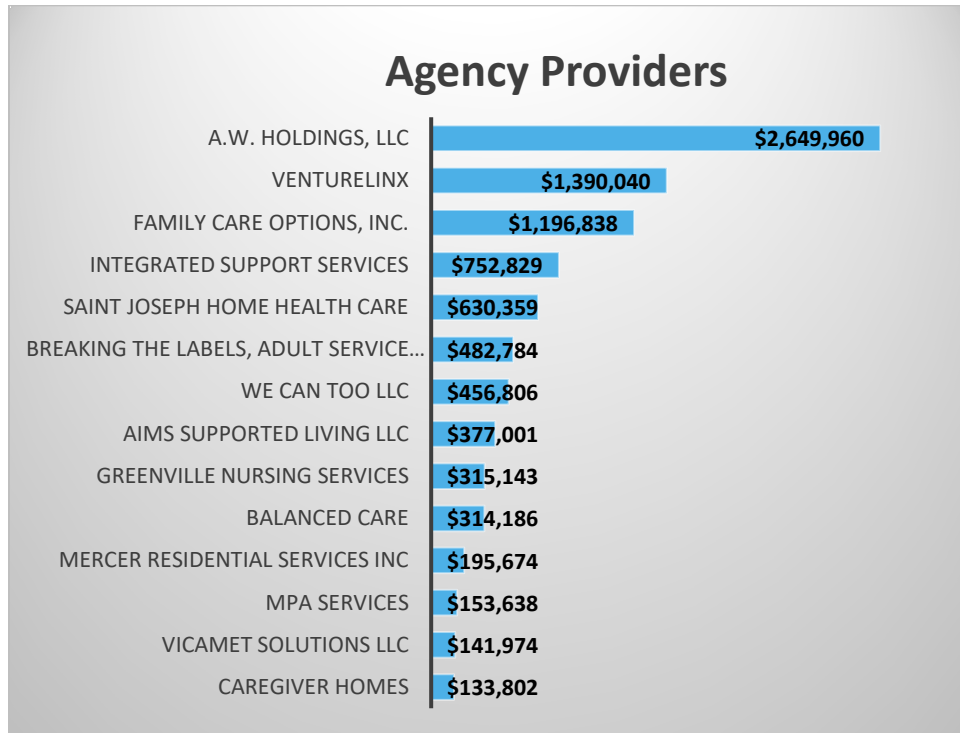

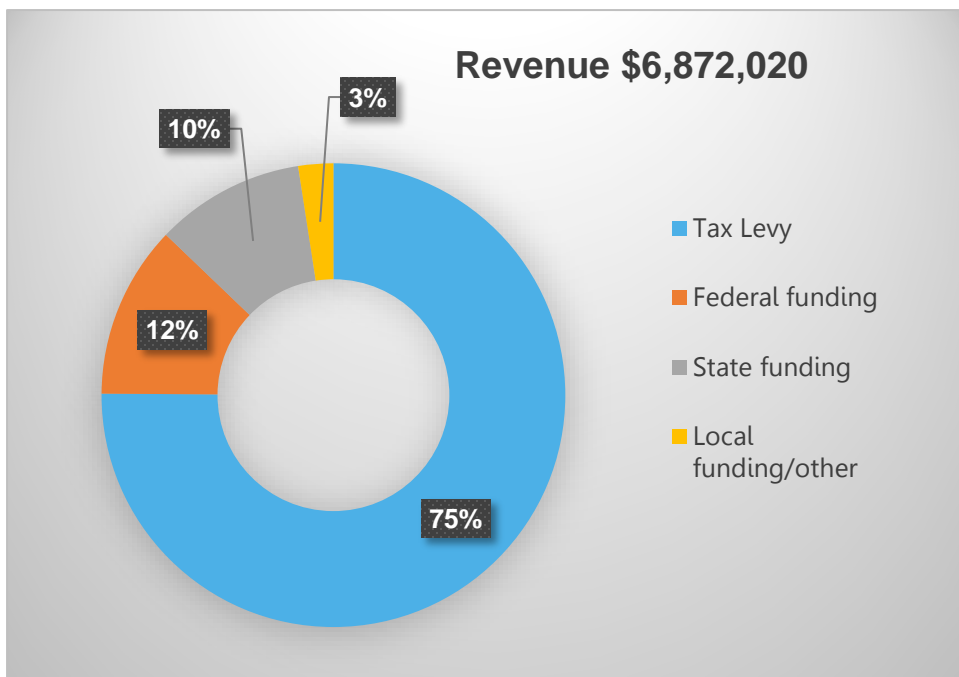
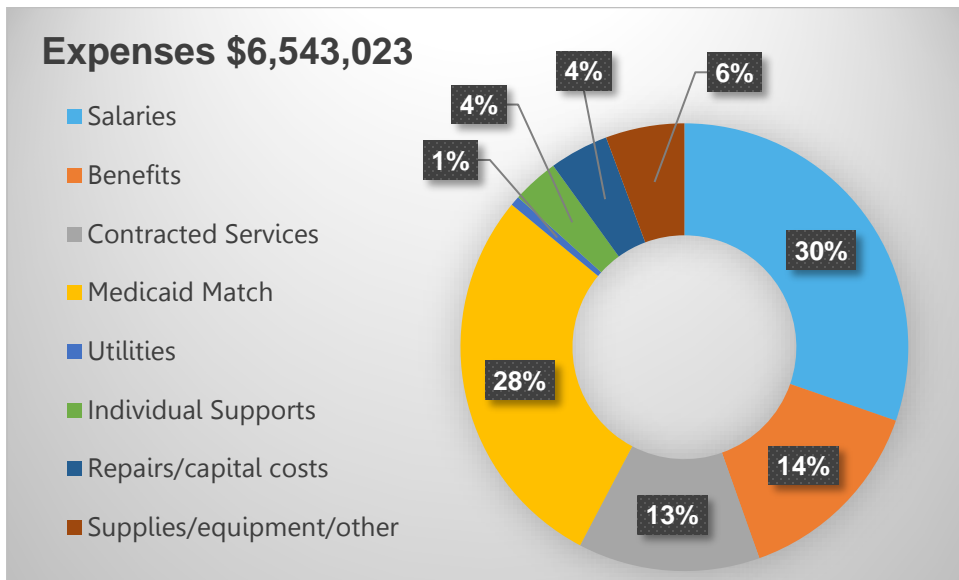

**WE CONTRACTED MEDICAID SERVICES WITH 40 INDEPENDENT PROVIDERS.**

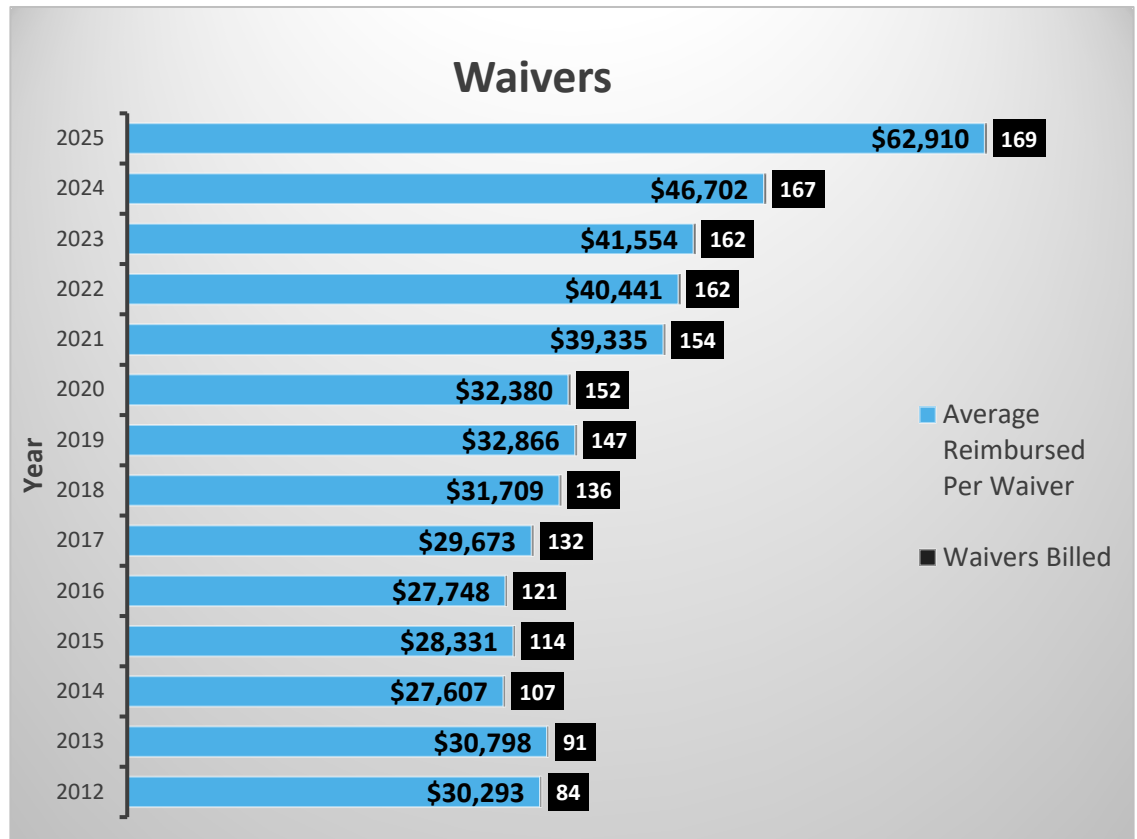
## FISCAL MANAGEMENT
